

Eligibility for CMES:

1. Should be a domicile of Manipur.
2. Should be unemployed.
3. Age should be more than 18 Years but less than 65 years.
4. Only one applicant per one Family **(Declaration Needed)**
5. Should not be a defaulter to any Nationalized Banks/financial Institution/Co-operative Bank.
6. Has not received more than Rs. 10 lakh of monetary support from Central Schemes or State Schemes. **(Declaration Needed)**.
7. Has not received subsidy from Startup Schemes, PMEGP, CMES etc. **(Declaration Needed)**
8. Must runs a registered business not older than 2 years.
9. Existing business that are older than 2 years are not eligible for this scheme except registered homestays which is approved by Department of Tourism.

Benefits:

- Support up to a project cost of Rs. 10 lakhs of which 30% is given as subsidy by the State under Manipur Start up fund. 65 % comes as loan component to be provided by the banks and 5% margin money to be contributed the business owner.

The fields that are Required for applying are given below:

1. Registration Requirements:

- a) AADHAAR number and AADHAAR linked mobile for OTP verification
- b) Working Mobile Phone for communication with SMS facility
- c) Working Email Id address.

Both the mobile phone number and email id will be verified using OTP.
