No. PLG1-3/5/2024-PLG-PLANNIG-Part (1): It is hereby notified that 04 number of beneficiaries have been selected and recommended for funding under Chief Minister Entrepreneurship Support Scheme (CMESS) - Special Package to Successful Start-Ups / Entrepreneurs for Employment of IDPs in Manipur. List of the beneficiaries is at Annexure.

- Bank shall provide 60% loan component of the approved project cost, for which 35% matching subsidy component (upto maximum of Rs.35.00 Lakh) will be provided by Government and remaining 5% margin money by the beneficiary concerned.
- 3. Beneficiaries shall strictly follow the following conditions in the implementation of the projects:
 - a) Selected Business unit will select / identify trainees/ Employees from their chosen relief camps and provide short term training/ skilling in their trade and employ them in their business.
 - b) Subsidy amount shall be deposited to partner banks as corpus fund by Planning Department after signing of MOU with the banks and selected Start Ups/ Beneficiaries.
 - c) Bank shall sanction loan within 15 days of signing MOU and submit copy of the sanction to the Planning Department.
 - d) Selected Beneficiaries shall finalize list of IDPs to be employed (verified by DCs concern or Nodal Officer of the relief camp) within 30 days after signing of MOU and submit to Planning Department with copy to Deputy Commissioner Concerned.
- Bank will release subsidy amount to the beneficiaries on pro-rata basis i.e. 35% matching subsidy of the loan component disbursed by the bank.
- Concerned bank(s) are to furnish quarterly report on disbursement of loan and subsidy beneficiaries by 10th of every month.
