For second instalment, beneficiaries are required to submit a prototype of the product, UC, Audited Statement of Account (ASA), claim for second installment, photograph showing signboard with the inscription "Sponsored by Planning Department, Government of Manipur under Idea Stage - Innovative category" along with startup registration ID to Planning Department. A Sub-Committee will appraise the documents and performance of the beneficiaries before release of the second installment.
