**No. PLG1-3/2/2021-PLG-PLANNIG:** It is hereby notified that a total of 11 candidates under Revenue category of Manipur Startup Scheme 2.0 have been shortlisted for appraisal by banks for sanction of loan component and 1 candidate under Standup category has been deferred. List of the shortlisted candidates for bank appraisal under Revenue category is at **Annexure-I** and list of the deferred candidate under Standup category of Manipur Startup Scheme 2.0 is at **Annexure-II**.

2. Shortlisted candidates listed at **Annexure-I** are requested to approach the banks of their choice/banks where their business transaction is carried out along with necessary documents and project plan.

3. Final selection for support of loan, subsidy component and project cost will be based on appraisal conducted by the banks. Bank shall provide 65% loan component, for which 30% matching subsidy component (upto maximum of ₹ 30.00 lakhs as per feasibility and viability of project proposal of the Enterprise) will be provided by Planning Department, Government of Manipur.

4. Bank shall release subsidy amount strictly on pro-rata basis, corresponding to the release of loan component (for both term loan and working capital). Banks shall indicate phase wise target release amounts (both loan and subsidy) to the beneficiaries in the sanction order. Banks are required to open a separate dedicated centralized account in the name of "Manipur Start Up Scheme" and furnish the following details.

- i. Name of the account holder (of the bank): Manipur Start Up Scheme;
- ii. Name of the bank (centralized for all branches) to receive subsidy;
- iii. IFS Code.

5. Banks are requested for early appraisal of these shortlisted candidates/enterprises given at **Annexure-I**. A copy of the sanction order issued to the beneficiaries indicating Startup registration ID and category under Manipur Startup Scheme 2.0 may kindly be forwarded to the Planning Department along with the following documents for early release of subsidy component.

- i. Loan account number of the beneficiary.
- ii. Copy of aadhaar card and PAN card attested by Bank Manager of the concerned Bank with seal.
- iii. Bank appraisal report attested by Bank Manager of the concerned Bank with seal.
- iv. Project Report attested by Bank Manager of the concerned Bank.

6. Subsidy amount corresponding to loan amount sanctioned by the bank will be transferred/credited to the dedicated centralized account of Manipur Start Up Scheme as details given in para 4. From the centralized account of Manipur Start Up Scheme, the bank will transfer subsidy amount to their bank branches that have sanctioned the loan component. The bank branches will then release subsidy amount to the Startup beneficiaries on pro-rata basis, i.e. 30% matching subsidy of loan component disbursed (installment-wise) by the bank.
